### 4. FIRST AID MEASURES

**Inhalation:** Remove victim to fresh air. Seek medical assistance.

Wear protective equipment to prevent skin and eye contamination. Contain to prevent run off to soil, drains and waterways. Use absorbent sand or other inert material. Collect for reuse if possible otherwise soak up with inert absorbent material and seal in properly labelled containers for disposal.

### 7. HANDLING AND STORAGE

**Handling:** Avoid skin and eye contact.

**Storage:** Store in a cool place and out of direct sunlight at a temperature between 10°C and 25°C. Keep containers closed when not in use – check regularly for leaks.

### 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Personal Protective:** The following personal protective equipment should be worn. Safety glasses, goggles or face shield as appropriate. Rubber gloves. Appropriate protective clothing.
